2007 IN/IL/WI Workshop Registration Form

I hope that the busy season went well for you. Below is the schedule for this year's workshops. The fee schedule has been structured so as to encourage **early enrollment**. This helps greatly in getting the planning and arrangements done with the various hotels. I especially encourage you to **register now** and attend the "**Spring Tax Update/New Tax Developments**" seminar in **June**. There have been a good number of developments in the way of new regs, cases and rulings, along with a number of key issues that arose in preparing our clients tax returns this year which we will have a chance to discuss during the session. For the fall, we will be going with a **2-day workshop** format and setting a date that's early enough so that important information can be covered in time to be used for yearend planning. If possible, I also hope to have someone from the respective state departments of revenue spend about an hour at the end of the first day covering local changes as well. The pricing for the fall workshop is listed for the two days, and I encouraged you to attend both days. But, there is some flexibility, if you decide to attend one day or the other.

Pricing: The cost of **June workshop** will be **\$165** for payment received by **5/21/07**; **\$175** for payment received thereafter. The cost for the **2-day fall workshops** will be as follows: **\$325** for payments received by **5/21/07**; **\$350** by **9/15/07**; and **\$375** for all payments received thereafter. If you plan to only attend one of the two days in the fall, you would still receive the manual which includes the information for both days and the cost would be as follows: **\$170** for payments received by **5/21/07**; **\$180** by **9/15/07**; and **\$190** for all payments received thereafter. As always, these prices include the cost of continental breakfast, lunch, and refreshments at breaks. There will also be a cocktail reception at the end of the first day of the 2-day workshops in the fall.
